FROM A DOCUMENT CONCERNING THE MASSACRES OF THE JEWISH POPULATION OF LEOVA RAION (REGION) BY THE FASCISTS $^{\rm 1}$

7 December 1944

...In the first half of July 1941, as soon as the locality of Leova Region was occupied by German and Romanian troops, the Jewish population of the city of Leova, 1558 people ², including children, were arrested at the instruction of Lt. Col Petr Georgievich Muntean of the 4th Romanian Border Guards Detachment, and sent in the direction of the city of Kishinev. On the way outside the village of Sarateni, at the instruction of the above Lt. Col. Muntean, 55 of the aforementioned Jewish population were shot as weak and elderly ³. One group of 20 people was shot in the northern part of the village 500 meters from Sarateni, and a second group of 35 250 meters from Sarateni. The bodies were not buried for a long time and after some time some ground was covered, as a consequence of which after three years the bodies had almost decomposed in the ground's surface. Thirty Romanian soldiers under the command of Lt. Col Muntean participated in the shooting.

The 2nd Romanian border guards detachment headed by Capt. Viktor Geolenscu passed through the territory of the Bestemac, Cazangic, and Sarata Noua village soviets (councils). At his instruction the entire Jewish population living in these village councils was arrested - a total of 210 people were arrested, of which 10 people were shot on the site. In the village of Cazangic, in the northern part, 300 meters away 78-year-old Yakov Markovich and his wife, Malka, of the same age were shot ⁴; in the village of Bestemac ⁵, also behind the village, in the eastern part, seven people were shot, a woman with three children; the rest were old men...

In the village of Sarata Noua, Ios'ko, the Secretary of the village council, was shot at the southern edge ⁶. Officers of this unit Gheorghe Stanculescu and Ion Ionescu participated in the executions. The bodies lay on the surface of the ground for a long time; in addition to this, at the instruction of Capt. Bolyanescu, eight beautiful women of the Jewish population were selected and sent to the village of Seliste, 500 meters from the village of Cazangic where they were raped for two days in a priest's empty house. Bolyanescu and two officers, Gheorghe Stanculescu and Ion Ionescu, participated in the rapes, after which the entire Jewish population was herded in the direction of Kishinev, their fates unknown...
