



CERTIFICATE OF INCORPORATION,
-of-
PODHAJCER RABBI SCHULIM LILIENTHAL ASSOCIATION, Inc.

We, the undersigned, being all over the age of twenty-one years and residents of the state of New York, and at least two-thirds of us being citizens of the United States, desiring to form a corporation pursuant to the provisions of the Membership Corporations Law, do hereby make, sign, acknowledge and file this certificate as follows:

1. The name of the corporation shall be PODHAJCER RABBI SCHULIM LILIENTHAL ASSOCIATION, Inc., the word "PODHAJCER" being the name of a certain village in the province of Galicia, in the Empire of Austria, and the words "RABBI SCHULIM LILIENTHAL" being the name of a Rabbi in that village.

2. The operations of the corporation shall be conducted principally in the City of New York, and the principal office is to be located in the Borough of Manhattan, City of New York.

3. The duration of the corporation shall be perpetual.

4. The objects for which this corporation is formed shall be to voluntarily aid and assist its members in times of sickness and distress; to promote the social and moral welfare and standing of its members; to disseminate among its members and to imbue them with the spirit and feeling of brotherly love; and to encourage thrift and frugality among its members.

5. The number of directors shall be twelve.
