My father, now deceased, changed his name to Larry Allen Gladstone when he started his medical practice in El Paso, TX. He was born Ladislav Glattstein on 26 September 1922 in Vysna Kamenica, Abauj-Turna, Slovakia. He had two sisters, Edith and Klara. Klara and her father died at Auschwitz. My aunt Edith survived Auschwitz. She also later lived in El Paso, TX until she and her husband made *aliyah*. She is now deceased. Her children all live in Israel.

My paternal grandfather was Julius (Gyula) Glattstein who was born in Vysna Kamenica, Abauj-Turna, Slovakia. He was born on 14 March 1884. He married my paternal grandmother, Anna Blaugrund. They resided in Vysna Kamenica until my father was about 7 years old. They moved to Munkacs so that my father could receive a sound education.

In Munkacs they moved into a home, a large one on a long piece of land with an orchard around 1929. (It was confiscated in April, 1944.) The home's address was 28 Ruzova Ulica. It was next to a Czech school called "Kohner Koshtey" and an empty lot.




Anna Blaugrund died before the war. My father believed that she had either uterine or ovarian cancer. She died when my father was a teen. My grandfather didn't re-marry. My aunt Edith had to quit school to maintain the household. The younger sister, Klara, was still young enough to need a mother figure.

My father, Ladislav Glattstein, was taken into forced labor during the war. His father and two sisters, Klara and Edith were sent to Auschwitz. His father was killed immediately. Klara died on 7 January 1944 in Auschwitz. Edith survived. My father was eventually liberated at Mauthausen (Austria) concentration camp, sub-camp Gunskirchen.


