

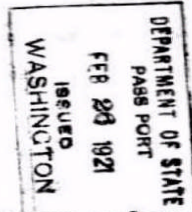

The original and each copy of an application for a passport must have attached to it a copy of the applicant's photograph. A loose signed photograph of the applicant must accompany the application. The photographs must be on thin paper, should have a light background, and be not over three inches in size.

22-This blank must be completely filled out. The legal fee of one dollar, in currency or postal money order, and the applicant's certificate of naturalization must accompany the application. The rules should be carefully read before making the application in the Department of State, Division of Passport Control, Washington, D. C.
